Vision: The Persons with different abilities should have equal Rights, Respect and Dignity to lead a better quality of life.

Mission: To provide need based Comprehensive Rehabilitation through multi-disciplinary approach and also to create barrier-free environment and ensure empowerment to the persons with different abilities and their families.

During the Covid-19 pandemic and the lockdown period it is severely impacted on mental health, education, livelihoods and social participation of persons with disabilities (PWD).

This organization distributed over 2500 dry ration kits and more than 5,000 hygiene kits in East Godavari District, Eluru, West Godavari District, Ongole, Prakasam District, Saluru, Vizainagaram District, Yanam Puducherry to help vulnerable sections of society especially to Persons with Disabled and their Families and the Migrants during the corona virus crisis.

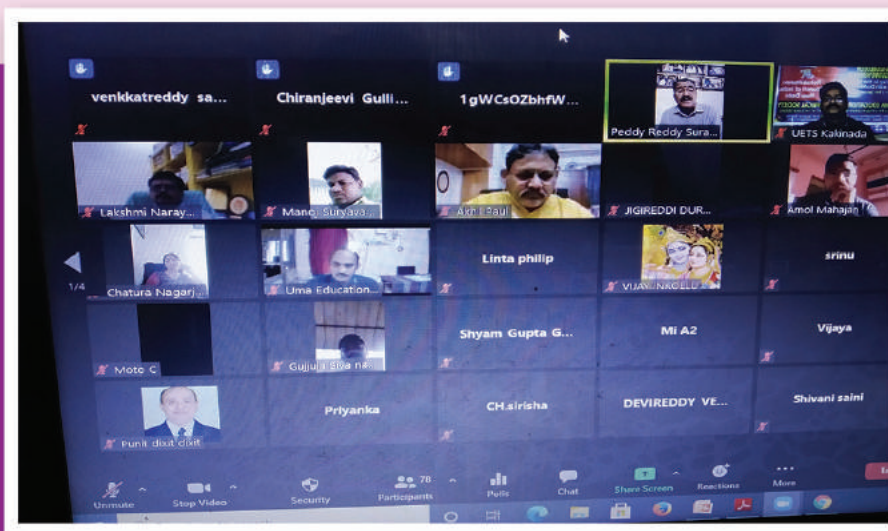
State Nodal Agency Centre (SNAC) is the institutional arrangements of the National Trust at the State/UT levels to support and take forward its activities. One SNAC in every State/UT is appointed from amongst the reputed and well established NGOs registered with the National Trust. Our organization has been selected as a State Nodal Agency Center (SNAC) for Andhra Pradesh for a period of three years from 01/01/2021 to 31/12/2023.

The COVID-19 pandemic has affected many areas in our lives. Following social distancing recommendations, many organizations have shifted their in-person conferences to virtual meetings. We also adopted these technologies and successfully conducted the three Continuing Rehabilitation Education (CRE) Programmes / National Conferences through Webinar with the approval of Rehabilitation Council of India, New Delhi during this year.

- ❖ 3 days CRE Programme on "Individualized Educational Plan (IEP)" from 5th to 7th November 2020 with 150 participants at National Level.
- ❖ 2 days Continuing Rehabilitation Education (CRE) Programme on "Role of play in the life of children with Db/MDVI" held on 18th and 19th January 2021 with 166 participants at National Level.
- ❖ 3 days Continuing Rehabilitation Education (CRE) Programme on "Intellectual Disability (Mental Retardation) Early Intervention-Interpretation of reports and implications for Program planning" from 21st to 23rd February 2021 with 100 participants at National Level.

Comprehensive Rehabilitation, Empowerment, Development and Livelihood for Spinal Cord Injury (SCI) Survivors in East Godavari district:

We have identified 86 Spinal Cord injured persons from 25 Mandals. Our DDRC, physiotherapist, clinical assessor, special educator have provided support to Spinalcord injured persons to assess their disability and appraised them regarding various schemes offered by Government of Andhra Pradesh. Physiotherapists are giving training about the exercises to the spinal cord injured Persons through physically and virtually every month. Also provided customized wheelchairs, financial support to 10 Persons with Spinal cord injuries @ Rs. 18000/- per beneficiary for their livelihood support as pilot projects with the support of Motivation India, Bangalore.





A Special Camp organized for Distribution of Aids & Appliances to needy persons with Disabilities at Koraput District in Odisha State:

Koraput is one of the districts coming under Odisha State where there is a lack of awareness regarding disability and services providing by the disability sector. They don't have enough knowledge about rehabilitation programs & sufficient income to go far-off places for treatment. In rural and remote areas there are no proper roads and public transportation to carry / shift the patients to nearby PHC or area hospitals and people take the patients by shifting on costs / carts to carry them for miles together. As such three NGOs who are working under District Child Welfare Society have came forward to organize a camp for distribution of aids and appliances to the needy persons with disabilities in coordination with District Disability Rehabilitation Center (DDRC), East Godavari District, Kakinada through the mobile workshop with the support of Carers Worldwide India in coordination with Ekta Foundation, Ward NGO & Spread Foundation conducted Assessment camps through Mobile workshop in different villages of Koraput District in Odisha State and distributed Aids and Appliances in the Month of Oct. 2020.

Faculty & Community development programmes were conducted to staff and PwDs by Sri Rama Krishna Surdeo who is an International Human Resource Development trainer. This training programme was held on milestones of life and how to build capacity for individual as well as organization, to identify strengths, knowledge, attitudes, linkage with team members, team work, weaknesses ,coordination and collective actions etc.

International Disabled Persons day celebrated at Uma Educational and Technical Society on 3rd December, 2020. The chief guest Sri.VadrevuKamaraju, Assistant Director, Welfare, Differently Abled, Trans-genders and Senior citizens of East Godavari District, explained the RPwD Act. Many differently abled children along with their parents have participated in the program and conducted variety of entertainment programmes like games, singing and dance competition. Children have taken part in these games with lot of enthusiasm and spirit.

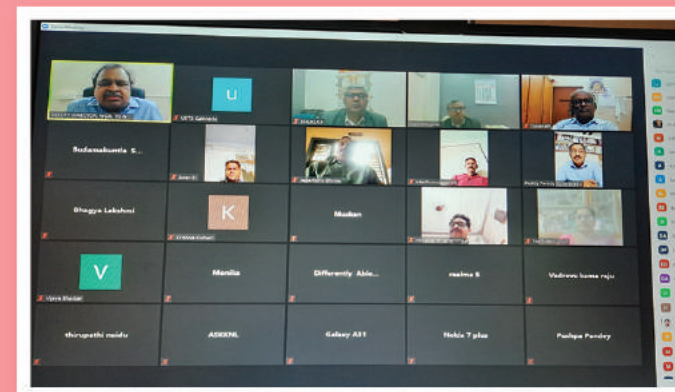

She appreciated and prised to Uma Educational and Technical Society, Kakinada for preparing the awareness posters and also suggested DDRC to make arrangements to display these posters at all ward and village Secretariats (Sachivalayas) in the district.

State Nodal Agency Centre (SNAC)-Andhra Pradesh has conducted a Virtual Meeting with Registered Organization and other stakeholders of National Trust pertaining to Andhra Pradesh on 15th Feb 2021. Shri.U.K.Shukla, Programme Director, Shri.Navanit Kumar, Deputy Director of National Trust, Shri.M.A.Kumara Raja Deputy Director, Department for Welfare of Differently abled, Transgender and Senior Citizens, Government of Andhra Pradesh have addressed the participants about the implementation of National Trust Act 1999 for strengthening the LLC's in all the 13 Districts of Andhra Pradesh, also to promote and issuing the Legal Guardianships.

On 24th February 2021 the children with special needs have participated in the district level sports conducted by Samagra Siksha Abhiyan at Meclarin High school ground, Kakinada. The sports events inaugurated by the Sri. D. Muralidhar Reddy, IAS, District Collector and Magistrate, East Godavari District. In this programme twenty nine child athletes from our centers have taken part in different events like Running, standing long jump, running long jump, Soft ball throw, Caroms, Shot-put, Bocce game, Javelin through, singing and mimicry etc. they have showed their inner hidden talents/skills and won the prizes.

An Orientation Training program conducted on how to utilize the customized Tricycle and wheelchairs by Mr.K.Praveen Kumar Reddy, Manager Programs & Mr.Sudhakar from Motivation India and also distributed Customized wheelchairs and Tricycles to the beneficiaries with the collaboration of Motivation India, Bangalore on 9th March 2021.

Conducted One day Training program for PwDs & their families along with other stakeholders belongs to Scheduled Caste, Tribe (SC/ST) Communities at Kakinada, East Godavari on 15th and 16th March 2021 at Eluru, West Godavari District, Andhra Pradesh under Public Private Partnership (PPP) for Scheduled Caste/Scheduled Tribe (SC/ST) Population on disability issues with the support of National Institute for Empowerment of Persons with Multiple Disabilities (Divyangjan), Chennai.



On 18th March 2020 SNAC Andhra Pradesh has conducted a Meeting with Registered NGOs and other Stakeholders of National Trust at Vijayawada. Sri. M.A.Kumara Raja, Deputy Director, Department for Welfare of Differently abled, Transgender & Senior Citizens, Government of Andhra Pradesh has attended as Chief Guest. 15 Registered Organizations, other Stakeholders Heads / under National Trust Act have participated. Sri S.P.Reddy, Founder and Executive Director, Sri K.Narayana Reddy, Project Director, Uma Educational and Technical Society, Sri Ch.ThirupathiNayudu, Coordinator, SNAC have presented about National Trust Act and its Schemes.

On 19th March 2021 Canara Bank, Regional Branch, Kakinada has Distributed 10 Customized Tricycles & Wheelchairs to the needy Spinal Cord injured Persons at Uma Educational and Technical Society, Kakinada. 10 Wheelchairs worth Rs.1,35,000/- were distributed to Spinal Cord Injured persons under Corporate Social Responsibility by the Chief Guest Sri. P Anil Kumar, AGM, Canara Bank, Regional Branch, Kakinada. Smt.K Padma, DM, Canara Bank Regional Office, Kakinada, Sri. I.V.Krishna Prabhu, Chief Manager, Canara Bank, Kakinada Main Branch, Sri. S.V.KrishnaRao, Senior Manager have participated in this program.

Special Schools for the Children with Intellectual Disabilities:

This organization is being providing Special Education and Rehabilitation Services to Children with Intellectual Disabilities at various places in the name of Uma Manovikasa Kendram at Kakinada and Ongole of Andhra Pradesh, The Early Intervention & Rehabilitation Centre for Special Needs Children at Yanam, Puducherry under the aegis of Ministry of Social Justice & Empowerment, Department of Empowerment of Persons with Disabilities (Divyangjan), Govt. of India, New Delhi with support of 90% Grant-in-Aid.

A Day Care Centre for Children with Intellectual Disabilities at Saluru in Vizianagaram district is also existing.

The main concept of these special schools is to provide Special Education & Rehabilitation services to the children with delayed developmental and intellectual disabilities. The following are the services providing to the beneficiaries at these centers.

Gharaunda – Group Home for Adults Intellectual Disabled

It is one of the National Trust scheme aims for setting up GharaundaCentres for life long shelter and care of persons with Intellectual Disabilities, Autism, Cerebral Palsy, and Multiple Disabilitiesunder National Trust Act. We are providing adequate and quality care services with acceptable living standards to 15 BPL beneficiaries which includes provision of basic Medical care, Vocational activities, pre-vocational activities and assistance for further training.

Deafblind State Centre – Andhra Pradesh:

Deafblind State centreis with the support of Azim Premji Philanthropic Initiatives (APPI), Bangalore through Sense International India is providing services like identification, screening, clinical and functional assessment (vision and hearing) and other various areas like sensory, mobility, communication and functional academics. This center is providing medical, nutrition, assistive devices, special education and vocational rehabilitation to Deafblind.

The following are the activities carried out during the session:

- Chaitanya Parents association was formed and registered under society registration Act in December 2020.
- 12 Spectacles were given to deafblind service users, 15 body type Hearing aids distributed to our service users through DDRC, UETS and SII.
- Conducted NGOs sensitization programme on deafblindness to five regional NGOs virtually on 20th October 2020.
- Organized training sessions on deafblindness to 50 Hearing impaired students and 15 teachers on 7th & 8th December 2020 at Maharshi Sambamurthy Institute of Social and Development Studies, Kakinada.
- Conducted training on deafblindness for Samagra Shiksha Abhiyan (SSA) teachers on 22nd February 2021 at SSA hall Kakinada.
- Conducted State level Advocacy and Network meeting with the support of Sense India successfully on 19th and 20th March 2021. About 40 govt. officials, parents of deafblind service users, adult deafblind and staff have participated in the two-days programme.
- As a part of COVID-19 relief activities, total 213 dry rations kits were distributed to services users with the support of SII, GiveIndia, APPI and PHF. Also 68 nutrition support kits were distributed to deserving service users.



District Disability Rehabilitation Centre, (DDRC), East & West Godavari Districts.

The DDRC is a scheme of Ministry of Social Justice and Empowerment, Department of Empowerment of Persons with Disabilities, Govt. of India, New Delhi. We are the implementing agency under the District Management Committee which is headed by the District Collector & Magistrate. It is providing several services for the welfare of persons with all categories of Disabilities. During this year we could not conduct screening camps at field level due to Covid-19 pandemic crisis.

The following are the activities carried out:

East Godavari District

- ❖ 534 members of Persons with disabilities could get services through this centre.
- ❖ A Special Camp organized for Distribution of Aids & Appliances to needy persons with Disabilities at Koraput District, Odisha State and provided 67 Assistive Devices.
- ❖ 149 new Assistive Devices were provided to needy PwDs.
- ❖ 162 nos. of Artificial Limbs / Calipers were repaired.
- ❖ Conducted Comprehensive Rehabilitation, Empowerment, Development and Livelihood for Spinal Cord Injury (SCI) Survivors with in East Godavari district and Identified 86 beneficiaries.
- ❖ Conducted 2 days Training & Orientation Program for Samagra Siksha Abhiyan Inclusive Education Resource Persons (IERPS) about types of Assistive Devices for Special Children.

West Godavari District

- ❖ 343 PwDs could get received various services through this centre.
- ❖ 501 new Assistive Devices were provided to needy PwDs through Department of Differently-abled, Senior Citizens & Transgender.
- ❖ 120 Dry Ration Kits distributed to poor PwDs
- ❖ Conducted Training & Orientation Programs on RPwD Act 2016 to Teachers and PwDs and their parents belongs to SC/ST Community.
- ❖ 110 beneficiaries have applied for their Unique ID Cards for Persons with Disabilities.
- ❖ 46 beneficiaries have applied for Aids & Appliances through Andhra Pradesh Differently-abled and Senior Citizens Assistance Corporation website.
- ❖ Celebrated all significant days, important occasions and events

Workshop (Immovable & Mobile) for fabrication/fitment of Assistive Devices.

Through this workshop (Movable & Immovable) the organization is fabricating and fitment of assistive devices and providing to the needy PwDs on free of cost with the support of Ministry of Social Justice & Empowerment, Govt. of India, New Delhi, Philanthropic organizations like GiveIndia, Mumbai, Motivation India, Reliance Industries Limited, Gadimoga, TTK Prestige Limited, Canara Bank Kakinada Branches and other Donors. Also providing door step services of Repairs & Maintenance of Aids & Appliances to the needy PwDs.

Community Based Rehabilitation Project for PWDs at Rampachodavaram:

Community-based rehabilitation (CBR) is to ensure that people with disabilities should have the same rights and opportunities like other community members. This includes equal access to health care, education, skills training, employment, family life, social mobility and political empowerment etc., CBR Programme is being implemented at Rampachodavaram Mandal, which is a hilly and tribal area with the support of Andheri Hilfe Bonn, Germany.

Key Achievements are:

- ◆ 48 new PwDs were identified and a total 628 PwDs are getting various services.
- ◆ 35 PwDs applied through online for SADAREM Disability certificates.
- ◆ 387 PwDs could get social security pension under YSR Pension Kanuka scheme @ Rs. 3000/- per PwD per month.
- ◆ 30 CwSNwere benefited from Ammavodi scheme of Rs. 15000/-
- ◆ 26 VDPOs were formed with 252 PwDs.
- ◆ 190 CwSN&PwDs were benefitted through home based intervention as per their needs and necessities also Parents and siblings were involved to impart training to their children.
- ◆ 150 PwDs were benefitted livelihood support from this project and Covid-19 relief.
- ◆ 550 PwDs were provided provision kits during the Covid-19 pandemic situation.
- ◆ 15 PwDs were benefited with marriage incentive and 15 PwDs got corrective surgeries and medication.
- ◆ 166 PwDscould get self-employment under MGNREGS for their livelihood opportunity.
- ◆ 135 women PwDsare benefited who have involved in Women SHGs.
- ◆ One VDPO has availed loan from the government through bank of Rs. 1,00,000/-
- ◆ Distributed 25 assistive devices toneedy PwDs.
- ◆ 22 PwDs and their members contested in local Panchayat elections, out of these 11 were elected as ward members and one as Grama Sarpanch.

District Disability Peoples Organization (DDPO):

Uma Educational and Technical Society, Kakinada has promoted District Disabled Peoples Organization (DDPO) in the name of Asharaya Zilla Vikalangula Samakya with the support of CBR Forum, Bangalore through CARITAS India, New Delhi. The main aim is forEmpowering PwDs through Promoting Leadership and Collective Initiatives in East Godavari District of Andhra Pradesh. 373 Village Disabled Peoples Organizations consisting of 3930 PwDs are under the jurisdiction of DDPO which includes 11 Mandal level DPOs covering 15973 PwDs who were benefited through rehabilitation services.

Key Achievements

- ◆ DDPO representatives had a meeting with Smt. Anuradha, IPS, Principal Secretary, Women and Child Welfare and Disabled Welfare department and requested about the RPwD Act 2016 rules to be discussed in A.P. Cabinet meeting for implementation. Received positive response from Principal Secretary.. (it is under process.)
- ◆ 13094 PwDs could get social security pension under YSR Pension Kanuka scheme @ Rs. 3000/- per PwD per month.
- ◆ 221 VPDOs are getting financial assistance from the Government of A.P. for their development.
- ◆ 128 CwSN were benefited from Ammavodi scheme of Rs. 15000/- each for those who are studying in general schools.
- ◆ Conducted two days training programme with 32 DDPO leaders on RPwD Act 2016 and secondary level leaders training.
- ◆ 25 PwDs were allotted house pattas under YSR housing scheme in this project area.
- ◆ Distributed ration kits for 3500 PwDs during COVID-19 crisis after generating funds from local donors.
- ◆ Distributed assistive devices (Wheel chairs, Tricycles, Mobility canes and Hearing Aids) to 80needy PwDs by mobilizing funds from local donors.
- ◆ 5 persons with differently abled have elected in local Panchayat elections in the project area.



State Nodal Agency Centre (SNAC) for National Trust:

State Nodal Agency Centre (SNAC) – Andhra Pradesh, Implementing Agency Uma Educational and Technical Society Kakinada has conducted the following programmes:
