Special Schools for the Children with Intellectual and Developmental Disabilities:

Special Education is providing for the students with special needs in such way that addresses the students' individual differences and needs. It is specially designed instruction that meets the needs of students with disabilities as they have to attend special schools, which includes related services and providing TLM and services. It helps every student with disabilities to have a chance to learn and show their own talent and intelligence.

Hence, this organization is providing Special Education and Rehabilitation Services to Children with Intellectual and Developmental Disabilities both daycare and residential at Kakinada, Ongole of Andhra Pradesh and an Early Intervention & Rehabilitation Centre for Special Needs Children at Yanam, Puducherry under the aegis of Ministry of Social Justice & Empowerment, Department of Empowerment of Persons with Disabilities, Govt. of India, New Delhi and local resources.

This organization is also maintaining a Day Care Centre for Children with Intellectual Disabilities at Saluru in Parvathipuram Manyam district.

Gharaunda - Group Home for Adults Intellectual Disabled

Group Home and Rehabilitation Activities under The National Trust Act for Disabled Adults are providing lifelong group home facility for all Adult PwDs covered under the National Trust Act with adequate and quality care services with acceptable living standards including provision of basic medical care from professional doctors. In this centre 15 BPL beneficiaries are receiving Pre-vocational and Vocational activities under the guidance of Local Project Committee (LPC) for effective implementation of the programme. For the purpose of mainstreaming and inclusion we are providing outreach programmes for them to develop psychological, emotional and behavioural approach. We are making them to involve in all social, significant and cultural events conducted by this organization.

Deafblind State Centre - Andhra Pradesh:

This organization is an implementing partner of Deafblind State centre with the support of Azim Premji Philanthropic Initiatives (APPI), Bangalore under CSR through Sense International India, Ahmadabad. This project is exclusively meant to provide Rehabilitation services to persons with Deafblindness and MD. DbSC has been providing special education and various services through Centre based, home based and community based by well qualified and well trained special educators. We are providing support services to various NGOs, SSA schools and special schools within the state.

This centre is taking initiatives in identification, screening, clinical and functional assessment (vision and hearing), early screening (new born baby screening) in collaboration with Srikiran Eye Hospital and Government General Hospital, Kakinada.

District Disability Rehabilitation Centre, (DDRC), Kakinada & Eluru Districts.

District Disability Rehabilitation Centre (DDRC) is an initiative by the Ministry of Social Justice and Empowerment, Govt. of India, to facilitate comprehensive services to Persons with Disabilities in the rural areas. We are the implementing agency for DDRC's at Kakinada & Eluru Districts of Andhra Pradesh. The DDRCs have conducted the programme in coordination with the Districts Management Committee which is headed by the District Collector & Magistrate. It is providing several services to the welfare of persons with all categories of Differently Abled.

Project for Breaking the Silence for PwMIs and Carers:

We are implementing a project called promoting access to regular for Persons with Mental Illness and their Carers for the holistic wellbeing in 9 Mandals of Kakinada and 1 Mandal ASR Districts with the support of Carers worldwide with the technical support of National Institute of Mental Health and Neurosciences (NIMHANS), Bengaluru. 558 PwMIs and 558 Carers are getting services in 10 Mandals through this project.

The project is having specific focus on:

- * To create accessibility for diagnosis and treatment for PwMIs
- * Transforming the emotional wellbeing and health of Carers
- * Increasing household economic security

The following are the achievements:

- 508 PwMIs were referred and getting Treatment/Medication
- Formed 52 Village Level, 10 Mandal Level and 2 District Level Carers Groups.
- · 3 Mental Health Camps were conducted in Pithapuram, U.Kothapalli and Tallarevu Mandals
- 9 Orientation and Training programs were conducted with Grama Volunteers and 450 Grama Volunteers have participated
- 65 Carers were provided financial support for livelihood activities.
- 298 PwMIs are getting SADAREM disability certificates and availing Social Security Pensions @ Rs.3000/- per month per person.
- 388 Carers and PwMIs are getting different schemes declared by the Govt. of Andhra Pradesh (Ammavodi, Cheyutha, Mastyakara Barosa, Aasara, Govt. schemes etc.,)
- Celebrated World Mental Health Day on 10th Oct 2022 at Mandal and District Level
- · Carers Day Celebrated on 19th Oct 2022.



Half Way Home for Psycho-Social Rehabilitation of Treated and Controlled Mentally III Persons:

This organization has executed effective services of Rehabilitation, Welfare, Promotion of Health, Vocational Training, Guidance & Counseling and Development of extracurricular activities for psycho-social rehabilitation of treated and controlled mentally ill persons through this project.

The project is aimed for providing vocational training and re-skilling persons with mental illness as well as counseling for them and their families to facilitate reintegration with the family/society. The project is expected to provide psychiatric/rehabilitation advice & services relating to their illness so that periodic or occasional psychiatric disturbances can be reduced. Accordingly we are providing services to 25 treated and Controlled Mentally III Persons at Kakinada.

College of Special Education:

It is required that the Rehabilitation Professionals are very much shortage and to meet the requirement of Special Educators in the field of disability, it has been running the following courses which are recognized by Rehabilitation Council of India, New Delhi in association with National Board of Examination in Rehabilitation, NIEPMD, Chennai, AYJNISHD, Mumbai, Adikavi Nannayya University, Rajamahendravaram and Dr. B.R.Ambedkar Open University, Hyderabad.


